



# Singapore Environmental Achievement Awards 2025, in its 26<sup>th</sup> edition, Celebrates Industry and Community Champions in Sustainability

### Singapore, 20 August 2025

Organised by the Singapore Environment Council (SEC), the 26<sup>th</sup> edition of the Singapore Environmental Achievement Awards (SEAA) continues its tradition of recognising outstanding contributions to environmental sustainability. Presented by the Minister for Sustainability and the Environment and Minister-in-charge of Trade Relations, Ms. Grace Fu, on 20 Aug 2025, the awards honour organisations that lead the charge in sustainable practices.

The organisations were assessed by an expert panel of judges, including Mr. Andrew Gan, President, The Cosmetic, Toiletry & Fragrance Association of Singapore; Mr Peter Goh, Chief Executive Officer, Navix-Schneider Electric; and Ms Isabella Huang-Loh, Chairman of Singapore Environment council. The assessment was supported by Grant Thornton Singapore, SEC's official assessment partner.

This year's awards are categorised by key dimensions of environmental performance: Systems and Management, Leadership and Advocacy, Innovation and Design. We are also highlighting the importance of community outreach via the Community Leader Environmental Recognition award.

## **Award Recipients:**

#### Razer Inc

Razer Inc was honoured with the <u>Outstanding Environmental Achievement Award</u>, alongside recognition as an Award Winner in <u>Innovation and Design</u>, and Merit Winner in <u>Systems and Management</u> as well as <u>Leadership and Advocacy</u>. The company was recognised for achieving a 90.77% global reduction in Scope 1 and 2 emissions, pioneering eco-labelled gaming products, and mentoring SME suppliers. Razer also developed the world's first ESG Lifecycle Assessment AI tool, which reduced the Environmental Product Declaration process from six months to just five minutes, transitioned 100% of its packaging to FSC-certified sources, and conserved over 1.4 million trees through sustainability education initiatives. These efforts demonstrate Razer's leadership in embedding sustainability across product design, operational systems, and corporate culture, inspiring industry peers while delivering significant environmental impact.

## • Constellar Venues Pte Ltd

Constellar Venues was honoured with the <u>Outstanding Environmental Achievement Award</u>, in addition to awards in <u>Systems and Management</u> and <u>Innovation and Design</u>. The company was recognised for transforming Singapore EXPO into one of Asia's most sustainable MICE venues through renewable energy, waste diversion, and circular design. Through its Go Green framework, Constellar integrates sustainability across operations—from green procurement to Scope 1–3 tracking—supported by Board and CEO-level governance. By





incorporating renewable energy, urban farming, waste management, and circular procurement at Singapore EXPO, the company has achieved significant reductions in carbon emissions, waste, and energy use per square foot, setting a benchmark for sustainable venue management in the region

#### Rentalworks Pte Ltd

Rentalworks Pte Ltd was honoured with the <u>Outstanding Environmental Achievement</u> <u>Award</u>, an Award Winner in <u>Leadership and Advocacy</u>, Merit Winners in both <u>Systems and Management</u> and <u>Innovation and Design</u>. The company was recognised for its comprehensive approach to sustainability, particularly in advancing circular IT lifecycle management, which has prevented over 16,500 kg of e-waste and saved 1.4 million kg CO<sub>2</sub>e. Rentalworks also actively engages in national and global sustainability programmes, promotes circular IT practices, and mentors suppliers through its Supplier and Partner Evaluation and Monitoring Policy. This multi-faceted commitment demonstrates leadership in operational excellence, innovation, and advocacy, while inspiring industry peers to adopt sustainable practices.

### • Gammon Pte Ltd

Gammon Pte Ltd was recognised as an Award Winner in <u>Systems and Management</u> and a Merit Winner in <u>Innovation and Design</u> for advancing sustainable construction through timber waste upcycling, low-carbon material test-bedding, and digital automation. The company employs real-time monitoring via its EPD and S-Dash platforms, achieving a 10% reduction in Scope 1 and 2 emissions and a 17% reduction in Scope 3 emissions, supported by AI, robotics, and centralised supply chain governance. These efforts highlight Gammon's commitment to integrating innovative technologies and robust management systems to drive measurable environmental improvements across its construction operations.

## OCBC

OCBC was recognised as an Award Winner in *Leadership and Advocacy* for embedding sustainability into governance, pioneering sector-specific green finance frameworks, and facilitating S\$9 billion in sustainable financing for more than 4,000 SMEs since 2020. The bank has also adopted the Poseidon Principles for maritime decarbonisation, demonstrating its commitment to driving sustainable practices across the financial and maritime sectors. Through these initiatives, OCBC exemplifies leadership and advocacy in promoting environmental responsibility while supporting industry-wide transitions to a low-carbon economy.

#### UOB

UOB was recognised with the <u>Leadership and Advocacy</u> Award for driving ASEAN's low-carbon transition, supporting SMEs through the SAGE Programme, advancing nature





financing via TNFD adoption, and co-leading the SSFA's Natural Capital and Biodiversity workstream. Through these initiatives, UOB demonstrates a strong commitment to integrating sustainability into its governance and operations while fostering environmental stewardship and promoting sustainable practices across the region.

## Mrs Namrita Chowdhry, PBM

Mrs Namrita Chowdhry, PBM was honoured with the <u>Community Leader Environmental</u> <u>Recognition</u> for her leadership of Henderson-Dawson Green Action for Communities, driving grassroots sustainability projects and events such as Riverside Vibes. Through her efforts, she has fostered environmental ownership among residents, agencies, and partners, inspiring community-wide engagement in sustainable practices and cultivating a culture of environmental responsibility
